Personal Protective Equipment (PPE) Policy - Campus Safety Services

I. Purpose

The purpose of the Personal Protective Equipment (PPE) Policy for Campus Safety Services is to minimize injury to Santa Clara University (SCU) employees through the proper use and care of personal protective equipment. It is designed to insure that SCU employees receive the correct PPE that they need, in the right size or style, understand its care, use and disposal and that is readily available to them.

II. Hazard Evaluation and Control

- 1. Periodic job surveillance shall be conducted to identify changing needs for the use of personal protective equipment (PPE). Changes that may affect the need or use of personal protective equipment (PPE) may include, but are not limited to, changes in the process, changes in the equipment (or materials), changes in the chemicals, changes in personal, changes in the surrounding environment and changes in the ways tasks are performed.
- 2. When assessing the need for personal protective equipment (PPE), the feasibility of engineering and administrative controls shall be considered first, as they are generally considered more permanent and eliminate the potential for human error.

III. PPE Equipment Guidelines

- 1. Minimum Daily Requirements that shall be worn
 - a. Shoes Closed Toe Shoes
 - b. Uniform University Supplied Khaki Pants/Shorts and Shirt
 - c. Traffic Vest Class 2 (Any time in a vehicle pathway such a parking lot, street, etc.)
- 2. Task Specific Requirements that shall be worn in addition to Minimum Daily Requirements

a. Abrasive Material Handling (e.g. Traffic Barricades)

i. Leather Gloves

b. When Providing First Aid

- i. Nitrile Gloves
- ii. Safety Glasses or Goggles
- iii. N95 Respirator
- iv. Face Shield (Optional)

c. Bicycle, Segway Personal Transporter or T3 Patroller

- i. Safety Glasses
- ii. Helmet fastened that meets Consumer Product Safety Commission (CPSC) for bicycle use.
- iii. Traffic Safety Class 2

d. Cutting Tools (e.g. Bolt Cutter)

- i. Safety Glasses
- ii. Face Shield (optional)

e. Traffic Control

- i. Traffic Safety Vest Class 2
- ii. Traffic Control Lighting Baton Nighttime Activities

3. Non-Specific Task Personal Protective Equipment (PPE) Requirements

For Non-Specific Task, please consult your Supervisor or EHS if you need additional assistance.

IV. Personal Protective Equipment (PPE) Maintenance, Storage and Cleaning

- 1. Personal Protective Equipment (PPE) repairs shall only be conducted by qualified individuals. Contact EHS if PPE needs repair.
- 2. Personal Protective Equipment (PPE) shall be stored in such a manner that is protected from factors that might degrade its performance. These factors include, but are not limited to sunlight, heat, extreme cold, excessive moisture, chemicals, dust and physical distortion
- 3. Personal Protective Equipment (PPE) (e.g. Not Uniform) shall not be taken home, unless prior authorization has been approved by your supervisor
- 4. All activities that involve the use of PPE shall be noted in CSS Duty Log.

V. Personal Protective Equipment (PPE) Responsibility

Personal Protective Equipment (PPE) shall be stored, maintained and inspected in an appropriate manner by each employee. If any personal protective equipment becomes damaged, please notify your immediate supervisor and it shall be replaced by the University. Should any questions or concerns arrive, Environment, Health and Safety (EHS) along with your immediate supervisor is available for consultation.
